



# 25 Years of Solar Power Generation Fraud

Are solar customers victims of fraud & forgery?

Across the country, prosecutors are investigating high-pressure sales tactics and misleading financing arrangements. Some customers say they were victims of fraud and forgery. The Consumer Financial Protection Bureau recently warned solar customers about hidden fees and deceptive statements about the financial benefits of solar.

What's happening with solar panel fraud?

One recent case that has sent shockwaves through the industry involves Vision Solar suddenly shutting its doors, and leaving thousands stranded, while one of its lender, Sunlight Financial, filed for bankruptcy on October 30th of this year. Solar panel fraud often begins with breach of contract issues.

Are 'upselling scams' causing a surge in solar panel fraud?

However, homeowners making the most of the Government's solar panel drive have increasingly fallen victim to conmen. Citizens Advice has warned of a surge in solar panel fraud, particularly "upselling scams" in which cold-callers convince customers to upgrade technology they already have to meet fabricated legal "standards".

Are customer complaints a problem in the solar industry?

Customer complaints against the country's residential rooftop solar industry have increased dramatically in recent years. One-star ratings on Solar Reviews increased more than 1,000% since 2018. Across the country, prosecutors are investigating high-pressure sales tactics and misleading financing arrangements.

Does rooftop solar have a fraud problem?

Who is liable for solar panel fraud?

Solar panel fraud doesn't stop with the companies directly involved; lenders also find themselves liable. Sunlight Financial, Vision Solar's lender, recently declared bankruptcy, leaving consumers in a precarious situation.
