This year's research budget has focussed on developing small nuclear reactors. While India needs to diversify its energy sources, the viability of such projects is still questionable. India needs to increase its R& D spending across the value chain, from renewable energy deployment to mining and extracting minerals to a circular economy.

There are a few new initiatives in the energy sector in the union budget 2024. Except for the announcement to set up a Critical Mineral Mission for domestic production, recycling of critical minerals, and overseas acquisition of critical mineral assets, the budget provisions in the energy sector are strengthening existing schemes.

Exemption from payment of surcharges and duties: the union government has provided a waiver from ISTS charges to promote the growth of the renewable energy sector in India. Any solar, wind and renewable energy hybrid systems, pumped-hydro-storage systems and battery energy systems commissioned by 30 June 2025 will be exempted from payment of ...
