Are solar panels a new opportunity to prey on consumers?

"As more Americans choose to lower their utility bills by adopting solar panels, fraudsters have found a new opportunity to prey on consumers," said Federal Trade Commission Chair Lina M. Khan.

Are solar companies causing consumer complaints?

Over the past decade, regulators have observed an increase in consumer complaints about some unscrupulous companies that pressure consumers into predatory contracts or purchases, including with unfair financing, and/or fail to install or activate residential solar systems as promised.

Did vision solar sell solar panels to consumers?

Vision Solar sold solar panel systems to hundreds of consumers, allegedly promising certain solar-energy benefits and fast timelines for project completion. Consumers instead reported experiencing extensive delays, damage, and empty promises.

Does the government offer free solar panels?

The government does not have any programs that offer totally free solar panels. However, several state and federal government programs can help you access solar energy equipment with lower upfront costs. These tax credits and incentives can reduce solar installation costs, making solar energy more accessible.

Will the CFPB scrutinize solar lenders?

"The CFPB will be scrutinizing solar lenders to make sure that Americans don't get burned." Expanded access to affordable, reliable residential solar is crucial for lowering energy costs and providing meaningful benefits for Americans.

The markup on solar panels varies depending on the manufacturer, model and panel type. The total cost of a solar project may include a markup of 200% to 300% -- especially for larger solar companies.

Solar PV isn't much help with winter power peaks. The bulk of solar generation is between 11am and 3pm.
