Do solar panels lock you in to a supplier?

Suppliers pay you through special tariffs. They used to be called "Feed-in-Tariffs" (FIT) - but this scheme was closed to new applicants from 1 April 2019. It's since been replaced by the Smart Export Guarantee (SEG). Whichever scheme you're part of, it's good to know that having solar panels won't lock you in to a specific energy supplier.

How much does a solar PV installation cost?

With the average cost of a solar PV installation around £6,500, some households may struggle to see financial benefits over the lifetime of the panels, although other environmental benefits may tip the scales. 1. Are solar PV installations sold between companies?

However, we are aware that in some instances solar PV installations are sold between companies, especially when companies go out of business. This change in ownership may not be communicated to the homeowner.

What happens when a solar PV contract ends?

When the contracts come to an end the customer can choose to remove the system, extend the PPA or purchase the energy system. On-site solar PV generation can take the form of either a large-scale rooftop installation on a commercial or industrial (C&I) site, or a ground-mount installation on adjacent land.

Can a third party install solar panels on a property?

The most common arrangement is that the third party installs solar PV panels on the property. The homeowner then receives the electricity generated (lowering their electricity bills) and the third party owner of the installation receives any associated subsidies, in this instance, FIT generation and export payments.

Do solar panels have a Smart Export Guarantee (SEG)?

The good news for solar panel owners is that large energy companies are obliged to pay for the excess energy that is exported, under the Smart Export Guarantee (SEG) scheme. What is the Smart Export Guarantee?
