

Customs declaration for solar generators

How do I make a customs declaration?

You can also check how to import or export goods. To make an import declaration you need to choose how to pay duties, VAT or excise. The Customs Declaration Service allows you to manage your customs financial accounts and download statements. You can also give authority to others to use your accounts.

Does the customs declaration service support import and export declarations?

The Customs Declaration Service supports making import and export declarations when moving goods into and out of the UK. All import declarations must now be made through the Customs Declaration Service. You can now start submitting all your export declarations through the Customs Declaration Service.

How do I make an export declaration?

You can now start submitting all your export declarations through the Customs Declaration Service. You'll need to use the UK Trade Tariff to help complete your import or export declaration. You can also check how to import or export goods. To make an import declaration you need to choose how to pay duties, VAT or excise.

Do I need a customs declaration to export goods from the UK?

To export goods from the UK to any country, including the EU, you need to make a customs declaration. It's essential you provide accurate information about your business and your shipment. For smaller businesses, it's often simpler to pay someone to look after this process, such as freight forwarders, customs agents or international couriers.

Do generators need a SEG tariff?

All generators who wish to receive payment for the electricity which they export back to the National Grid will need to apply to a SEG licensee (an electricity supplier which offers a SEG tariff). SEG licensees must offer a SEG tariff to all eligible generators.

Who is responsible for a customs declaration?

The buyer/importer of the goods will lodge an import declaration with the customs authorities in the receiving country, who will confirm and determine if the goods need to be inspected and if all information is correct and therefore if the goods can be released to the importer. 10.
