Will Biden use Defense Production Act to accelerate solar energy production?

The White House said Biden will authorize the use of the Defense Production Act to accelerate manufacturing of solar panels in the United States as a way to strengthen the administration's efforts to shift the country toward clean energy.

What is the Defense Production Act?

The Defense Production Act lets the federal government direct manufacturing production for national defense and has become a tool used more commonly by presidents in recent years. The Trump administration used it to produce medical equipment and supplies during the early stages of the coronavirus pandemic.

What does Biden's solar policy mean for the US?

White House officials said Biden's actions aim to increase domestic production of solar panel parts, building installation materials, high-efficiency heat pumps and other components including cells used for clean-energy generated fuels.

Will Biden give a two-year tariff exemption on solar panels?

What does the Tariff Act mean for the solar industry?

The Tariff Act allows the Commerce secretary and president to take emergency actions to ensure the reliable supply of solar components from southeast Asian countries, which play a key role in the production of solar panels. The solar industry has welcomed this move.

In early June the Biden Administration invoked the Defense Production Act in an effort to rebuild America's domestic solar energy manufacturing supply. Simultaneously, the Administration announced that it will prohibit for two years new tariffs on imports of solar cells from four Southeast Asian countries that are under investigation for ...
