

Export declaration requirements for energy storage containers

When is a combined export declaration required?

This is sometimes referred to as a combined export declaration. When Safety and Security requirements have not been met by means of a combined export declaration, an EXS is required when: - an empty pallet, container or vehicle is being moved under a transport contract goods have remained in temporary storage for more than 14 days

When do I need a Customs Export declaration?

Most exports will have safety and security requirements met with the customs export declaration which contains safety and security information. This is sometimes referred to as a combined export declaration. When Safety and Security requirements have not been met by means of a combined export declaration, an EXS is required when: -

Do I need a safety and Security Export declaration?

Export safety and security information will be required on all other movements out of Great Britain, unless permanently exempt. You can find out more information about exceptions and when to make an exit summary declaration. Safety and security export declarations are not required for goods moving from Great Britain to Northern Ireland.

Who must make an export declaration for a fixed transport installation?

(1) An export declaration for goods exported using a fixed transport installation must be made by or on behalf of the operator of that installation or the consignor of the goods.

How long does an export declaration have to be made available?

(1) Goods, in respect of which an export declaration has been made, must be made available for examination at an appropriate place within a period of 30 days beginning with the day on which the declaration was made. (2) But paragraph (1) does not apply to goods which are exported by being transported through a fixed transport installation.

Do I need a supplementary export declaration?

I67 Reg. 33 in force at 31.12.2020 by S.I. 2020/1643, reg. 2, Sch. 34. A supplementary export declaration is not required, to comply with the simplified export declaration process, in respect of goods where-- (a) the value of the goods does not exceed €900 and the weight of the goods does not exceed 1000kg;
