Does Florida offer solar incentives?

The state encourages its residents to install solar panels, although it doesn't rank in CNET's list of seven best states for solar incentives. Florida is one of only three states that offer property-assessed clean energy loans for solar.

What is a solar rebate & grant?

The rebate/grant is based on solar panel system capacity. Residents can get \$0.25 per watt of solar power generated up to a maximum of \$2,500. Yearly funds are distributed on a first-come, first-served basis, and projects must be completed and permitted by Oct. 1 each year.

The tax credit is scheduled to step down to 26% in 2033 and to 22% for systems installed in 2034. The federal tax credit expires in 2035 unless renewed by Congress.
