Where can you complain about a solar company?

Part of the reason is that many customers who feel victimized don't know where to turn. "There's not really one place for consumers to complain to," says Jenifer Bosco, an attorney with the National Consumer Law Center. "If they do have a problem with solar companies, they can complain to the Federal Trade Commission.

Do solar companies have a Consumer Protection Bureau?

Some states also have consumer protection bureaus where consumers can file complaints. While the advisories are an attempt to educate consumers, previous government efforts to regulate solar companies have fallen short.
