



# How to ship lithium batteries to alaska

Although battery types like lithium metal batteries, lithium-ion batteries and others are all technically different, for the purposes of shipping they are largely seen as the same and all rules, recommendations, and restrictions generally apply to all types. Examples of lithium battery shipping labels.

USPS Packaging Instruction 9E Lithium Metal and Lithium-ion Cells and Batteries -- International and APO/FPO/DPO. Lithium metal (non-rechargeable) cells and batteries and lithium-ion (rechargeable) cells and batteries are mailable in limited quantities internationally or to and from APO, FPO, or DPO locations only when they are properly installed in the equipment they operate.

Lithium ion batteries are categorized in Class 9 of Hazardous Materials, so you'll need to follow certain regulations if you want to ship them domestically and internationally. I've been looking at the LiTime batteries. They offer free shipping via UPS to the lower 48 but will not ship to AK. I know these batteries cannot go air, but what's not clear is if they can be shipped via UPS/Fedex/USPS via ground.

Shipped out of USA. When shipping papers (Bill of lading forms, Dangerous Goods Declaration forms) are required, all lithium battery shipments to, from or through the United States must have written emergency response information accompany the shipment.

I was looking at LiTime's battery sale. They only ship to lower 48 via UPS. I contacted their CS and they confirmed they cannot ship to Alaska. Looking at UPS/Fedex/USPS websites it's not clear if the batteries can be shipped to AK via ground. I know they cannot be shipped via air freight.

Shipping Lithium Batteries. Open or Close content below Live Animals. Except in limited circumstances, pets and warm-blooded animals may not go in the mail. Shipments of live animals, including poultry, reptiles, and bees, have very specific packaging requirements.

The lithium batteries must be of a type that have successfully passed the UN38.3 tests and contain the necessary systems to prevent overcharge and over discharge between the batteries.

Note. Effective July 1, 2015, all existing customers and new customers who wish to ship lithium metal batteries without equipment (UN3090) via UPS &#174; Air services must obtain pre-approval from UPS Airlines. This requirement is to ensure that proper training has occurred and that all applicable safety regulations are properly followed for such shipments.

Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations. In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3).

Here are some key factors to consider when shipping electronics with lithium batteries. Batteries must be contained in the electronic device. It is okay to ship lithium batteries as long as they are properly installed in the device they were meant to operate. Such packages also do not require special documentation or Lithium Battery Safety ...

Batteries ARE LEGAL to ship via air in specific quantities and cell sizes via USPS. Amazon just avoids the whole issue. For domestic mailings only, small consumer-type primary lithium cells or batteries (lithium metal or lithium alloy) like those used to power cameras and flashlights are mailable domestically under certain conditions.

While UN Model Regulations set the foundation for lithium battery shipping globally, individual countries and regions often have additional and potentially stricter regulations in place. This means any state (Alaska and Hawaii) or territory that requires air shipping cannot have lithium batteries shipped via air. The only exceptions are if the batteries are contained within a device. The reason for this change is the discovery that lithium batteries can catch fire or even explode under certain atmospheric conditions, and the ...
