A viral story revives a falsehood about Nancy Pelosi's brother-in-law and a federal loan guarantee for a Nevada solar plant.

Did Ron Pelosi get a loan from Tonopah Solar Energy?

Yes, Tonopah Solar Energy received a loan for a project in Nevada. At that time, Ron Pelosi was a board member with a subsidiary of Pacific Corporate Group, an investment partner in Tonopah's parent company.

Did Pelosi get a \$737 million loan?

As we wrote in 2011, the \$737 million loan guarantee from the Department of Energy was not provided to Ron Pelosi (which the story later names) but to a subsidiary of SolarReserve, for the Crescent Dunes solar facility in Tonopah, Nevada -- a project that supported 600 construction jobs and created 45 permanent jobs, according to the department.

Are Nancy Pelosi's sons a board member of energy companies in Ukraine?

The sons/stepsons of Nancy Pelosi, John Kerry and Mitt Romney are not, and have not been, board members of energy companies doing business in Ukraine.
