Nebraska Public Power District is beginning the process of studying sites that could have the potential to host advanced small modular nuclear reactors, it said on Jan. 13. Under Nebraska legislative bill 1014, the State of Nebraska allocated \$1 million of American Rescue Plan Act funding to complete a siting study for small modular reactors.

Nebraska Public Power District announced earlier this month its goal of being decarbonized by 2050. The decision aligns NPPD with the state's other major electrical providers - Lincoln Electric System and Omaha Public Power District - in their net-zero goals. In the third public involvement phase, NPPD determined a proposed route and presented it at a public hearing, followed by a 30-day comment period. A final line route will be announced no earlier than thirty days after the public hearing, at which time, right-of-way activities and final design work will begin.
