Determine whether installing solar will affect your property taxes. New York State Real Property Tax Law 487 provides a 15-year real property tax exemption for renewable energy systems. However, some municipalities and school districts have opted out of the exemption, meaning residents who install solar may have to pay additional property taxes.
