What is the value of Ostro Energy & re-New Power Ventures?

Sumant Sinha-led Re-New Power Ventures has finalised the takeover of Ostro Energy for an enterprise value of INR10,800 crore (\$1.66 billion), the biggest M&A deal in the renewables sector, sources close to the deal said.

How much is Ostro Energy Private Limited worth?

Indian renewable energy project developer ReNew Power has announced the acquisition of Ostro Energy Private Limited. The acquisition is valued close to INR10,600 crores (~\$1.63 billion), according to Mercom's channel checks.

Will renew power & Ostro Energy build a new wind power plant?

Neither ReNew Power nor Ostro Energy was willing to confirm the development. Ostro Energy, set up in June 2014, has commissioned wind assets of 648 MW and another 350 MW are in the pipeline.

How many MW is Ostro Energy generating?

Ostro Energy, set up in June 2014, has commissioned wind assets of 648 MW and another 350 MW are in the pipeline. It is also building around 110 MW of solar projects, making it a total of 1,108 MW across the states of Andhra Pradesh, Telangana, Karnataka, Rajasthan, Gujarat and Madhya Pradesh.

What is Tata Power Renewables & Ostro Energy?

Before this deal, Tata Power Renewables's acquisition of Welspun Energy was the largest in the sector at Rs 90 billion. Actis PE fund-backed Ostro Energy has a capacity of over 1,100 Mw, of which 850 Mw is commissioned. Its solar and wind projects are spread across Andhra Pradesh, Karnataka, Telangana, Rajasthan, Madhya Pradesh and Gujarat.
