Will Real Goods Solar file for bankruptcy?

Real Goods Solar Inc. decided Jan. 31 to liquidate its business and start planning to file for Chapter 7 bankruptcy in the U.S. Bankruptcy Court for the District of Colorado.

What happened to Real Goods Solar?

The board of Real Goods Solar fired CEO Dennis Lacey and "determined to cease all business activities, to terminate all of the company's employees, and to commence a plan of action" to file for Chapter 7 bankruptcy in Colorado, where the company was headquartered. The company's share price had been in the tank for years.

Does RGS Energy still exist?

January 31, 2020 RGS Energy filed for bankruptcy on January 31, 2020 and no longer exists. Real Goods Solar Inc. OTCQX: RGSE was a publicly traded residential solar power integrator doing business as RGS Energy.

Will Real Goods Solar sell shingles?

In March 2019, Real Goods Solar disclosed that it had begun exploring strategic alternatives including a sale of the company, a merger or a strategic investment financing to support its business plan for commercializing solar shingles.

Does Real Goods install solar panels in California?

Since Real Goods was now headquartered in Colorado, yet maintained the SLC, SLI and offices in California, and since the federal government and both states offered attractive tax incentives for installing solar systems, Real Goods opened its residential solar system installation division in both states in 2002.

How did Real Goods Solar start?

A decade earlier, Real Goods Solar grew organically and through acquisition and pulled in tens of millions of dollars in revenue. Four decades ago, the company helped kick off the residential solar phenomenon by supplying panels to off-grid dwellers in the remote forests of Mendocino County, California.
