



Renewable energy rfp

The IGP RFP seeks proposals for a variety of variable and firm renewable energy and capacity resources on Oahu and Hawaii, including, but not limited to, wind, solar, geothermal, biomass and biofuels. Standalone energy storage proposals also will be accepted. The IGP RFP seeks to have projects in service by December 1, 2029 and December 1, 2033.

On March 17, 2022 at 4 pm HST, Hawaiian Electric issued its Community-Based Renewable Energy (CBRE) Phase 2 Request for Proposals (RFP) for Low- and Moderate-Income (LMI) subscribers, in accordance with Order No. 38217 (PDF) issued on February 8, 2022 in the CBRE docket (2015-0389).

The Office of Energy Efficiency and Renewable Energy is the largest investor in clean energy technology development in the U.S. Government. During the Biden Administration, EERE has published FOAs totaling over \$3.8 billion and has selected promising proposals to receive more than \$884 million in awards.

Acquisition Proposals Only. In the solar category, one new aspect of this year's RFP is that Dominion Energy is seeking proposals within its service territory for non-residential rooftop solar development or mechanically complete projects, specifically on commercial, industrial and government-owned structures.

DEEP conducted its first procurement of renewable energy in 2011 using authority from Section 127 of Connecticut Public Act 11-80, which directed that 30 MW of Class I renewables be procured through an open, competitive RFP, and the state's EDCs were authorized to own and operate no more than 10 MW each of that authority.
