Who is Saritha S Nair?

Who is Saritha Nair & Biju Radhakrishnan?

Saritha Nair was the second accused in the case related to the infamous scam. Judicial first class magistrate-III K Nimmi acquitted the third accused B Manimon, while the verdict of Biju Radhakrishnan, the first accused in this case, was put on hold for pronouncement later as he had applied for leave for being under quarantine.

What was the 2013 Kerala solar panel scam?

The 2013 Kerala solar panel scam occurred in 2013, when a solar energy company, Team Solar, in Kerala, India, used two women to create political contacts with links including to the Chief Minister's office.

Was team solar unsuccessful in lobbying Kerala Govt to get ANERT programme?

Team Solar was unsuccessful in lobbying Kerala Govt to get their firm included in ANERT programmes. The Team Solar Energy Company (Team Solar), floated by the main accused Biju Radhakrishnan and Saritha. S.

Who is Saritha Nair & Tenny Joppan?

The chief accused, Saritha Nair and one of the Chief Minister's personal aides Tenny Joppan has been fired and arrested. The director of the Public Relations Department, who allegedly received Rs 500,000 from the Team Solar man, has been suspended and has gone underground fearing arrest.
