



# Sending a lithium battery by post

Can I ship lithium batteries via USPS?

#1: Yes, you can ship lithium batteries via USPS. However ... There are currently six types of lithium batteries eligible for shipment, in varying domestic or international quantities, via USPS: Don't forget the new lithium battery marks that became mandatory this year!

How do I ship a lithium battery?

USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information: All packages containing lithium metal or lithium-ion batteries that can be mailed must be of sufficient size, sealed, and rigid. This ensures that the lithium battery mark can be affixed to the address without folding.

Can I ship lithium batteries overseas?

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

Can I ship a lithium battery by Air Service?

Shipping lithium batteries by air service Regulations differ depending upon what type of lithium battery you are shipping (lithium ion or lithium metal) and whether you are shipping batteries packed with equipment or batteries contained in equipment. Reminder: UPS does not accept Section II shipment

Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check here.

Do I need a Dot label to ship lithium batteries?

USPS Packaging Instruction 9D Lithium Metal and Lithium-ion Cells and Batteries -- Domestic. Except according to 349.21, lithium metal (nonrechargeable) cells and batteries and lithium-ion (rechargeable) cells and batteries are mailable in limited quantities domestically via air or surface transportation when they are installed in or packed with the equipment they are intended to ...

Sending lithium batteries overseas. Shipments of electronic items containing lithium cells and batteries are prohibited when sent using the International Courier product. You cannot send lithium batteries to Bhutan, Germany, Italy, Laos, Macao or Thailand. If you do, your item will be refused or returned to sender. Check our International Post ...

Class 9 Lithium Battery hazard label. Lithium batteries of a certain size need a Class 9 hazardous materials label. Lithium Battery Mark. Batteries may also require a lithium battery mark that includes the UN ID number and a phone number to call for additional information about the shipment. Cargo Aircraft Only (COA) label.

Sending lithium batteries in the post. Whether shipping batteries to anywhere in the UK or overseas, following these three initial steps will make the process easier: 1. Gather information. Before posting lithium batteries, it is useful to note down details that the carrier might need:

Lithium batteries sent separately from equipment; Damaged or recalled batteries; All pre-owned, damaged, or defective electronic devices containing or packaged with lithium batteries ... When sending medicine or drugs through the mail, mailers and shippers must know the characteristics of the items they are sending and treat them correctly ...

Note. Effective 1 July 2015, all existing customers and new customers who wish to ship lithium metal batteries without equipment (UN3090) via UPS &#174; Air services must obtain pre-approval from UPS Airlines. This requirement is to ensure that proper training has taken place and that all applicable safety regulations are properly followed for such shipments.

Lithium batteries. These might be rechargeable, such as those you'd find in phones and laptops, or non-rechargeable, including watch and car key fob batteries. Either way, lithium batteries are a potential fire hazard. You can only send them with us if they're contained securely within the device they power. Fragrances.

The maximum number of lithium batteries allowed in each parcel is the minimum number required to power the device plus two spares; For lithium ion/polymer batteries the Watt-hour rating must not exceed 20Wh per cell or 100Wh per battery; For lithium metal/alloy batteries the lithium content must not be more than 1g per cell or 2g per battery

Some areas may restrict you from sending lithium batteries entirely, while others will put limitations on the types of batteries you can send. Make sure the country where you're shipping batteries isn't banned, ... Visit the post office to send 2 ...

Effectively, when shipping any lithium batteries you should ensure you adhere to the Dangerous goods regulations. 3 days ago&#0183; 3. International Restrictions: International battery shipments have more stringent regulations due to safety concerns. USPS prohibits shipping lithium batteries internationally via mail. However, you can send other non-spillable and spillable batteries internationally, subject to specific packaging requirements and restrictions imposed by the destination country.

You can also send lithium batteries in the UK when they're sent with their device (except in their Royal Mail Tracked Returns, Business Response, Freepost, Royal Mail 24 and Royal Mail 48). These regulations from the Royal Mail follow those set down by the United Nations and International Air Transport Association (IATA).

A table in the Lithium Battery Shipping Regulations manual gives the precise weight of batteries per package on both cargo and passenger aircraft. All marks and labels must be clearly visible on the exterior of all packages and overpacks. Proper marking and labeling is required when shipping lithium batteries by air.
