Can You ship lithium batteries to Hawaii?

If you've lived in Hawaii for any length of time, you know that shipping items to the state can present some challenges. Some stores don't ship to Hawaii, while others tack on exorbitant fees. Still others are willing to ship to Hawaii--but exclude certain items. What kind of solutions are available for shipping lithium batteries to Hawaii?

Can I ship a lithium battery by Air Service?

Shipping lithium batteries by air service Regulations differ depending upon what type of lithium battery you are shipping (lithium ion or lithium metal) and whether you are shipping batteries packed with equipment or batteries contained in equipment. Reminder: UPS does not accept Section II shipment

Does ups ship recalled batteries to Hawaii or Puerto Rico?

Does ups ship lithium ion batteries?

This label indicates what the contents of the shipment are, and UPS won't accept the package into their network without it. Of course, UPS also allows for air transportation of lithium-ion batteries if they're packed within the equipment they power (just like USPS does).

Does USPS ship lithium-ion batteries?

USPS isn't the only game in town when it comes to shipping lithium-ion batteries; you can use other carriers like UPS, too! The thing is, UPS also considers lithium-ion batteries as a type of hazardous material, so you'll need to follow a certain process when it comes to shipping them. We've laid out what you need to do below.

Do I need a contract to ship a lithium ion battery?

Service limitations may apply for some shipments of lithium ion batteries.
