



# Solar companies in liquidation

Will SunPower's bankruptcy affect the residential solar market?

Roth, of MKM, sees SunPower's struggles as a potential positive for other big solar companies like SunRun and Sunnova. But there's also a chance that SunPower's troubles could further shake the residential solar market. If it falls into bankruptcy, its financials will be closely examined.

Is SunPower bankruptcy a liquidation of SunPower?

"Although technically this bankruptcy process is Chapter 11 (restructuring) rather than Chapter 7 (liquidation), in effect it is a liquidation of SunPower," said Raymond James analyst Pavel Molchanov.

When will SunPower sell its assets?

The sale of SunPower's assets is expected to be completed by late 2024, marking the end of a company that was founded in 1985. As the solar industry continues to evolve, the collapse of a major player like SunPower serves as a reminder of the volatility and competitive pressures in the renewable energy market.

What happens if you own a SunPower solar system?

Complete Solaria made a Stalking Horse bid for some of SunPower's assets. The company intends to liquidate its remaining assets elsewhere. The organization(s) that purchase SunPower's solar lease and PPA assets will likely assume responsibility for servicing those systems. If you own your SunPower system, you may lose some warranty protections.

Should SunPower pay for a solar system lease?

One local SunPower customer posted an emailed letter he had received from the company on social media which stated that he should now send payments for his SunPower solar system lease to a company called Launch Servicing.

What happens if a solar company goes bankrupt?

If the company goes bankrupt, other companies could take over management of owners' systems. But in some cases in which solar companies have gone bankrupt, consumers are still waiting, sometimes with broken systems, to find out what comes next. SunPower, of the nation's biggest solar installers, is no longer selling leases.

If they are dissolved, the company no longer exists or functions. Therefore, you will need to find an alternative solar maintenance provider. The fact of the matter is that very many solar-related companies have gone out of business. In fact, it is estimated that over 80% of domestic solar installers have gone out of business since 2011!

In February 2024, the company raised \$8 million in seed funding to boost its new climate fintech strategy, focusing on tech advancements, product innovation, and solar installer skill development. Meanwhile, Hohm"s parent company, Spark Energy, clarified that there was a misunderstanding regarding the capital raise.

One of Australia's largest rooftop solar installers, Metro Solar, has suffered financial collapse, with notice published last week that the Victoria-based company had been put into liquidation ...

Solar firm SunPower said it had filed for Chapter 11 bankruptcy protection in the United States and agreed to sell some of its business to Complete Solaria for \$45 million in cash.

Solar company, Hohm Energy, has entered voluntary liquidation with the Companies and Intellectual Property Commission (CIPC). The company, which entered business rescue in July 2024 due to financial difficulties, informed creditors of the decision this week.
