Who sold our solar modules in 2022?

What if a solar energy system is sold to the IRS?

The maximum potential future payments that we could have to make under this obligation would depend on the difference between the fair values of the solar energy systems sold or transferred to the funds as determined by us and the values that the IRS would determine as the fair value for the systems for purposes of claiming ITCs.

How much solar energy will be produced by 2030?

Based on these targets, it is projected that the solar energy generation capacity will be 300 GW AC by 2030. The government has also announced a series of policy and regulatory measures to incentivize domestic manufacturing of PV solar modules, as described below under "Support Programs."
