What is the \$7 billion solar for all program?

Under the \$7 billion Solar for All program, the 60 grant recipients will create new or expand existing low-income solar programs, which will enable over 900,000 households in low-income and disadvantaged communities to benefit from distributed solar energy.

Who will receive a \$7 billion solar grant?

Washington - Today, April 22, as the Biden-Harris Administration celebrates Earth Day, the U.S. Environmental Protection Agency announced 60 selectees that will receive \$7 billion in grant awards through the Solar for All grant competition to deliver residential solar projects to over 900,000 households nationwide.

What is community solar?

A new Environmental Protection Agency program is giving \$7 billion to programs that fund rooftop solar panels, batteries to store solar energy and something called community solar. David Widawsky at the EPA says community solar allows renters and others who can't install panels to tap into solar energy generated at a shared site, like a solar farm.

What is solar power in your community?

The program will reduce 30 million metric tons of carbon dioxide equivalent emissions cumulatively, from over four gigawatts of solar energy capacity unlocked for low-income communities over five years.

Last December, First Solar agreed to sell roughly \$650 million of these credits to a tech company -- providing a massive influx of cash, courtesy of the U.S. government.
