



# Solar panel companies filed

Can you sell solar panels if you don't work for a company?

In most states, anyone can knock on your door and try to sell you solar panels, even if they don't actually work for a solar company. (Solar companies contract out sales to something called dealer networks that are essentially sales shops.)

Which solar companies have failed this year?

Most of the solar panel companies will file what is called a UCC (Uniform Commercial Code) statement with the secretary of state to notify other creditors that there is a secured lien on their property. It creates a lien against the collateral so if your home is sold, their lien gets paid off.

When signing a solar lease or PPA (Power Purchase Agreement), you are basically renting the solar panel system. With a lease or PPA, a UCC-1 financing statement will be filed with the agreement and a lien will be placed against the panels.
