Are lithium batteries allowed on Southwest Airlines?

UN3090 Lithium Metal Batteries are FORBIDDEN on passenger aircraft per IATA/ICAO USG-02 and 49CFR,173.185 (c). UN3480 Lithium Batteries are prohibited per Southwest Airlines policy. Here are two additional resources to the specific regulations and/or guidance pertaining to the transportation of lithium batteries:

Are lithium batteries allowed in checked baggage?

Travel Ban: Lithium batteries that are damaged, defective, or recalled for safety reasons are not allowed in checked baggage, carryon baggage, or cargo. For additional information on recalls, please visit United States Consumer Product Safety Commission.

Can you carry a lithium ion battery on a plane?

Lithium-ion batteries, including those in laptops and power banks, are allowed but limited to 100 watt hours per battery, with the option to carry up to two larger 101-160-watt-hour batteries with airline approval. Lithium metal (non-rechargeable) batteries are permitted up to 2 grams of lithium per battery.

How much lithium can a battery hold?

Lithium metal (non-rechargeable) batteries are permitted up to 2 grams of lithium per battery. All batteries must be protected from damage and short circuits, such as by keeping them in their original packaging or using tape to cover the terminals.

Not nearly as many as you'll find inside the terminal though.
