



Stamp Duty on Solar Power Generation

What is stamp duty land tax (SDLT)?

Stamp Duty Land Tax (SDLT) may apply in connection with the grant of a lease for airspace or roof space for the installation of solar panels where the landlord is given a right to receive energy in return. This is a freeview 'At a glance' guide to SDLT and renewable energy leases.

What's new in stamp duty land tax?

The Stamp Duty Land Tax rates and threshold dates have been updated in the Staged Payments section. Purchase deadlines extended for reduced rates for Stamp duty Land Tax. The government has temporarily increased the nil rate bands of residential Stamp Duty Land Tax from £125,000 to £500,000.

Does stamp duty land tax (SDLT) still apply in Wales?

From 1 April 2018 SDLT will no longer apply in Wales. You'll pay Land Transaction Tax which is dealt with by the Welsh Revenue Authority. Find out what transactions to include in the amount you use to work out Stamp Duty Land Tax (SDLT).

What are the new nil rate bands of stamp duty land tax?

The government has temporarily increased the nil rate bands of residential Stamp Duty Land Tax from £125,000 to £500,000. The section on staged payments has been updated to include links to the current and previous Stamp Duty Land Tax rates. From 1 April 2018 SDLT will no longer apply in Wales.

When will solar panels pay back to the grid?

New rules introduced this week will give homes and businesses that install solar panels payments for exporting electricity back to the grid from 1 January 2020.

Can a resident use a solar PV array if they don't use electricity?

The wording of the exemption does seem to allow for scenarios where the resident (s) don't directly use the electricity they produce - perhaps because they go out to work when the solar pv array is generating electricity and therefore use mostly use 'normal' mains electricity from the National Grid when they come home in the evenings.

In the 2024-25 State Budget, the electricity duty for prosumers was increased from 1.2 paise to 15 paise per unit. Solar prosumers were subsequently exempted from this duty, as outlined in the ...
