

Is there an uptick in Chinese corruption cases?

However, while there was "no doubt there has been an uptick" in cases targeting the investigators themselves, there did not appear to be evidence of a particular political clique or faction being targeted, said Andrew Wedeman, an expert in Chinese corruption at Georgia State University.

What is the gap between state capture and traditional corruption?

For some OECD economies, such as the United States, Britain, Chile, and Hungary, the gap between (higher levels of) state capture and traditional corruption is particularly wide. What is GRI sustainability reporting?

Applies the GRI Sustainability Reporting Guidelines or the GRI Standards. Applies elements of the International Integrated Reporting Framework. Is anti-corruption a key national security interest?

The Biden-Harris Administration has designated anti-corruption as a core national security interest and released the first-ever U.S. Strategy on Countering Corruption.

Are China's anti-corruption cases 'low-profile'?
