Who will receive a \$7 billion solar grant?

Washington - Today, April 22, as the Biden-Harris Administration celebrates Earth Day, the U.S. Environmental Protection Agency announced 60 selectees that will receive \$7 billion in grant awards through the Solar for All grant competition to deliver residential solar projects to over 900,000 households nationwide.

What is the \$7 billion solar for all program?

Under the \$7 billion Solar for All program, the 60 grant recipients will create new or expand existing low-income solar programs, which will enable over 900,000 households in low-income and disadvantaged communities to benefit from distributed solar energy.

Is solar for all a national program?

Some states and communities have already had Solar for All programs, but the \$7 billion in grants authorized by the Inflation Reduction Act and awarded this week by the US Environmental Protection Agency will allow for a national adoption of the model. What is Solar for All?

How much will solar energy save a community?

This \$7 billion investment will generate over \$350 million in annual savings on electric bills for overburdened households. The program will reduce 30 million metric tons of carbon dioxide equivalent emissions cumulatively, from over four gigawatts of solar energy capacity unlocked for low-income communities over five years.

What is a solar for all grant?

New grants for Solar for All programs aim to install solar panels and boost community solar access nationwide. Here's the list of grantees near you. Community solar projects such as this one are one pillar of the new widespread Solar for All projects.

Is solar for all a state program?

Though the federal government's Solar for All cash infusion means additional comprehensive state-level programs will start being funded in the coming months, there aren't many programs at the state level at this time. If you live in Illinois, New York or Washington, D.C., you may be eligible to apply to state Solar for All programs.
