Does Virginia need local authority to approve solar projects?

The Virginia Association of Counties opposes the bill. The group argues that local review and approval of utility-scale solar, wind and battery storage projects is necessary to make sure they fit the locality's land-use objectives. The state should not usurp local authority to make that decision, the association said.

Why should Virginia invest in domestic solar?

However, global supply chain issues and reliance on foreign imports pose significant risks to our energy security. Recognizing this, Virginia is committed to developing strategic partnerships and investing in domestic solar manufacturing to reduce dependence on foreign sources.

What is Virginia's solar energy plan?

As part of Governor Youngkin's all-American, all-of-the-above energy plan, solar energy is integrated alongside other energy sources like nuclear and natural gas to ensure a reliable, affordable, and increasingly clean energy future for Virginia.

How much solar energy does Virginia produce?

In 2023, Virginia ranked as the 9th largest producer of solar energy in the United States. Today about 13% of Virginia's total power is generated from solar plants (EIA, 2024), with more on the way as additional large scale solar facilities come online over the next decade.
